Resolution Setting County Elected Official Salaries

On a motion by Commissioner Robert E Lee and second by Commissioner Douglas D Martens in Regular Session on August 28, 2012 it carried to unanimously approve the following County Elected Official salaries for the fiscal year beginning July 1, 2012 and ending June 30, 2013.

WHEREAS; Section 7-4-2504 MCA requires the county governing body to fix salaries of all elected officials;

THEREFORE, BE IT RESOLVED; The salaries will be increased as recommended by the Rosebud County Salary Compensation Board by 4% per county official. The salaries will thus be as follows:

- The County Clerk of the District Court, Justice of the Peace shall receive \$48,613.64 base salary.
- The County Superintendent of Schools shall receive \$49,013.64 base salary.
- The County Attorney, as a full-time County Attorney, shall receive \$95,563.57 base salary.
- The County Commissioners, Clerk and Recorder, Treasurer and Sheriff will receive \$50,613.64 base salary.
- The County Coroner shall receive \$424.00 and Deputy Coroners shall receive \$318.00 per month.
