RESOLUTION #872

SPECIAL EMERGENCY FIRE RESTRICTION – STAGE 1

WHEREAS; Counties are currently experiencing increased fire activity due to fuel conditions getting very dry, the chance of ignition increases daily as the fuels are drying out. Fire danger levels are expected to continue in the range between very high and extreme; and

WHEREAS; The rapid onset and movement of fire may require Incident Commanders and law enforcement agencies to act immediately and at any time to protect persons and their property; now

BE IT FURTHER RESOLVED; that Rosebud County Commissioners is declaring a Stage 1 Fire Restriction to be effective Thursday, June 28, 2012, and be in effect until further notice. The following acts are prohibited:

- 1. Building, maintaining, attending, or using a fire or campfire except within a developed recreation site, or improved site.
- 2. Smoking, except within an enclosed vehicle or building, a developed recreation site or while stopped in an area at least three feet in diameter that is barren or cleared of all flammable materials.
- 3. County wide ban on the use of all fireworks.

EXEMPTIONS:

- a. Persons with a written permit that specifically authorized the otherwise prohibited act.
- b. Persons using a fire solely fueled by a liquid petroleum or LPG fuels.
- c. Persons conducting activities in those designated areas where the activity is specifically authorized by written posted notice.
- d. Any Federal, State, or local officer or member of an organized rescue or firefighting force in the performance of an official duty.
- e. All land within a city boundary is exempted.
- f. Other exemptions unique to each agency.
