RESOLUTION #888

RESOLUTION SETTING PER DIEM POLICY & STANDARD MILEAGE RATES

WHEREAS Rosebud County has not changed their per diem policy since January 3rd, 2013, and;

WHEREAS Rosebud County seeks to deviate from the per diem meal rates established by the State of Montana, Section 2-18-501, M.C.A.; and

WHEREAS Rosebud County has authority to establish County policy for reimbursement of meal and lodging expenses and per diem rates for County officers and employees who travel for County business. (40 Op. Atty Gen Mont. No. 77);

NOW THEREFORE IT IS RESOLVED THAT EFFECTIVE JANUARY 1, 2013, THE PER DIEM POLICY FOR ROSEBUD COUNTY IS AS FOLLOWS:

The motel room policy of Rosebud County is to utilize 'State rate' motel rooms whenever possible. Motel reimbursement rates generally will not exceed the state rate of \$77.00 per night plus tax, except as the State of Montana has adjusted the rate for high cost areas.

Rosebud County recognizes a higher rate of reimbursement may be necessary when traveling to meetings and conferences in and out of state in higher cost areas. A County official or employee may request prior approval for actual expenses to attend a meeting in a high cost city. The request will be reviewed and approved or denied by the Commissioners on a case by case basis.

Trip reports and motel receipts must be submitted with each reimbursement claim.

The meal per diem policy for Rosebud County officials and employees is as follows:

Without a receipt the County will reimburse at the state meal rates, Section 2-18-501, M.C.A., namely Breakfast \$5, Lunch \$6, and Dinner \$12 for a total of \$23 per day.

With a receipt the County will pay the face value of the receipt for the meal of the County official or employee up to a maximum of the standard federal rate of Breakfast \$7, Lunch \$11, and Dinner \$23 for a maximum of \$41 per day. The County does not reimburse for tips or gratuities, nor does the County reimburse for alcoholic beverages.

The standard federal per diem rate also includes \$5 for daily incidental expenses, however the County does not pay a flat rate for incidental expenses. To be reimbursed, specific incidental expenses (such as parking) must be supported by a receipt noted as part of the travel claim.

AND WHEREAS the standard mileage rate established by the federal government has been increased to \$0.565 cents per mile for business travel, the federal mileage rate is adopted by Rosebud County for County business travel by a County official or employee utilizing a private vehicle.

NOW THEREFORE BE IT RESOLVED that the rates set forth above rates will go into effect on March 19, 2013, and thereafter will follow any adjustments made by the State to the rates set forth in Section 2-18-501, M.C.A.

Commissioner Lee presented a request from the National Association of Counties to pass a resolution supporting the nomination of Hon. James D. Healy to the National to the National Freight Advisory Committee. Commissioner Martens said that he believed that a Resolution should only be passed when it pertains to important county business. A RESOLUTION CONFORMING PRECINCT BOUNDARIES TO LEGISLATIVE DISTRICT BOUNDARIES FOLLOWING THE ADOPTION OF THE 2013 LEGISLATIVE DISTRICTING PLAN UNDER ARTICLE V SECTION 14 OF THE MONTANA CONSTITUTION

WHEREAS, this Resolution was introduced by Geraldine Custer, Rosebud County Clerk and Recorder, moved by Commissioner Martens, and seconded by Commissioner Joiner. The Resolution was adopted unanimous.

WHEREAS, on February 12, 2013, the Montana Districting and Apportionment Commission adopted the final Legislative Districting Plan and filed the plan with the Montana Secretary of State;

WHEREAS, the Montana Secretary of State filed the submitted plan on February 12, 2013;

WHEREAS, M.C.A. §13-3-102(1), requires that precinct boundaries conform to legislative boundaries following the adoption of a districting and apportionment plan under Article V, Section 14, of the Montana Constitution within 45 days of the filing of the final plan, which is March 29, 2013;

WHEREAS, a map of Rosebud County showing the boundaries of the precincts has been completed after the 2013 final Legislative Districting Plan was filed;

WHEREAS, M.C.A. §13-3-103(1) sets a limit of not more than 10 days after the date of the resolution changing the boundaries of an election precinct, to deliver a written legal description and a map showing the borders of all precincts and districts in which elections are held within the county to the election administrator, which is April 8, 2013;

WHEREAS, M.C.A. §13-1-204(2) requires the election administrator provide precinct information and maps in the form and at the time prescribed by the secretary of state;

WHEREAS, the Secretary of State has provided a timeline requesting the new precinct maps be sent by April 15, 2013;

WHEREAS, the timeline provided by the Secretary of State requests changes to the statewide voter database (MT Votes) be completed by July 15, 2013.

NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED:

- (1) The map, attached as Exhibit A, shall set forth all precinct boundaries for Rosebud County, Montana in conformance with the 2013 final Legislative Districting Plan on file with the Montana Secretary of State;
- (2) That pursuant to M.C.A. §13-3-103(1), the map, attached as Exhibit A, showing the borders of all precincts and house districts shall be forwarded to the election administrator;
- (3) That pursuant to M.C.A. §13-3-103(1), a written legal description of each precinct boundary shall be forwarded to the election administrator by April 8, 2013;
- (4) That according to the timeline provided by the Secretary of State, the precinct information for Rosebud County will be updated in the statewide voter database by July 15, 2013;
- (5) The new precinct boundaries will become effective for all elections conducted after July 15, 2013.

Commissioner Joiner motioned to approve and sign the Trust Agreement, Active Landfill Financial Assurance (FA) Montana Department of Environmental Quality Waste & Underground Tank Management Bureau Solid Waste Program. Discussion followed with Commissioner Lee explaining that this agreement sets aside money in trust to cover the cost of closure and clean up of cells at the county landfill. He explained that each year funds are added to the trust, to assure that the county will be able to cover all costs related to closure. The funds are currently being held by First Interstate Bank Wealth Management. Commissioner Martens seconds motion, motion carried, 3-0.
