WHEREAS, solid waste disposed at the landfill has been declining;
WHEREAS, the landfill is classified in the BARS system an enterprise fund which must be supported by fees for its operation;
WHEREAS, due to increased maintenance costs and the loss of one disposal contract, the landfill fees must be increased;
WHEREAS, the Solid Waste Board and the Commissioners propose to increase the Unit Fee to \$85.00;
WHEREAS, a public hearing was held on August 21, 2018;
NOW, THEREFORE BE IT RESOLVED, after taking public comments both oral and written, the Board of County Commissioners moves to adopt the above fees;
BE IT FURTHER RESOLVED, this Resolution becomes effective August 21, 2018.
