Commissioner Martens motioned to approve the Montana Stock Growers Association's Memorandum of Understanding allocating \$10,000 for the protection of cattle from destructive animals. Commissioner Martens motioned to approve the Montana Wool Growers Association's Memorandum of Understanding allocating \$599.40 for the protection of sheep from destructive animals. Commissioner Joiner seconds motion. Discussion included that this is the same amount as allocated last year. Motion carried 3-0.

Commissioner Martens motioned to award the bid for Chip Seal 3 miles of roadway on Cartersville / Little Porcupine Road to Century Companies, Lewistown, MT for the amount of \$121,962.50. Commissioner Joiner seconded motion. Discussion included that this was the only bid received and that the bid was reviewed and approved by Wayne Buck, Road Department Foreman. Motion carried; 3-0.

Commissioner Martens motioned to award the bid for the New Horizontal Impact Crusher to Titan Machinery, 1728 Old Hardin Road, Billings, MT for the amount of \$358,000 after trade value. Resolution Setting County Elected Official Salaries

On a motion by Commissioner Martens and seconded by Commissioner Joiner in Regular Session on June 27, 2019, it carried to unanimously approve the following County Elected Official salaries for the fiscal year beginning July 1, 2019 and ending June 30, 2020.

WHEREAS; Section 7-4-2504 MCA requires the county governing body to fix salaries of all elected officials;

THEREFORE, BE IT RESOLVED; the salaries will be increased as recommended by the Rosebud County Salary Compensation Board. The salaries will thus be as follows:

- The County Clerk of the District Court, Justice of the Peace, Clerk and Recorder, and Treasurer shall receive \$59,736.44 base salary + \$2,000.00 to equal \$61,736.44.
- The County Superintendent of Schools shall receive the elected officials' base salary, or \$59,736.44 + \$400.00 annually for a total of \$60,136.44.
- The County Attorney, as a full-time County Attorney, shall receive \$113,567.72 base salary.
- The County Commissioners and Sheriff will receive \$61,736.44 base salary.
- The County Coroner shall receive \$561.81 per month and Deputy Coroners shall receive \$432.97 per month.
