WHEREAS; RSID # 7373, RSID #7374, and RSID #7375 were paid off several years ago;

WHEREAS; SID Revolving Fund #3300 was set up when RSID bonds were sold;

WHEREAS; there is left over money in the above-named funds;

WHEREAS; Since the RSIDs were paid off years ago, there is no longer any need for these funds;


WHEREAS; It is the desire of the County to take the remainder of these funds and transfer into the General Fund and close these accounts;


NOW THEREFORE BE IT RESOLVED; The County Treasurer will close RSID #7373 which has a balance of \$.04; RSID #7374, which has a balance of \$6,189.58; RSID #7375, which has a balance of \$4663.99; and SID Revolving Fund 3300, which has a balance of \$47,766.21;

BE IT FURTHER RESOLVED; The total Balance of the above-named funds which is \$58,619.82 will be transferred to the General Fund.
