The Board of County Commissioners of Rosebud County, Montana, met in Regular session on August 11th, 2020 at 10:00 a.m. in the Rosebud County Courthouse Commissioners’ Office, with Robert E. Lee, Presiding Officer, Douglas D. Martens, Member, Ed Joiner, Member, and Clerk & Recorder, present.

No public comments were received as no public was present for the meeting.

Commissioner Martens motioned to approve the consent agenda, to include all claims and approve July minutes. Commissioner Joiner seconds motion, motion carried, 3-0.

Commissioner Joiner motioned to accept the terms of the Great Plains Resources oil lease for eight hundred acres in Northern Rosebud County for ten dollars. Commissioner Martens seconds motion. Discussion included Commissioner Martens stating that currently the well is not producing but anything they do will benefit the county. Motion carried, 3-0.

Commissioner Joiner motioned to approve Resolution 1083 which allows an alternative voting option for the General Election in November. Commissioner Martens seconds motion. Discussion included Commissioner Joiner stating that the county has had trouble getting election judges due to the pandemic, the facilities typically used for voting locations do not want people there. Provisions have been made for the tribe, using a drop box for registration or ballots. The Courthouse is available for in person voting. Commissioner Martens stating that he does not agree 100%, but given the difficulties due to the pandemic this is our safest option for the county. Motion carried, 3-0.

Resolution 1083 as follows:

RESOLUTION NO. 1083

A RESOLUTION CALLING FOR THE NOVEMBER 3, 2020 GENERAL
ELECTION ALTERNATIVE VOTING PROCESS

WHEREAS, due to the global outbreak of COVID-19 Novel Coronavirus, on August 6th, 2020, Governor Bullock of the State of Montana issued a directive implementing Executive Orders 2-2020 and 3-2020, permitting counties to conduct the November 3rd, 2020 General Election under the mail ballot provisions of Title 13 Chapter 19, and suspending Section §13-19-104(3)(a), MCA, this purpose only; and

WHEREAS, Governor Bullock's directive recognizes that the Centers for Disease Control and Prevention has urged states to "encourage voters to use voting methods that minimize direct contact with other people and reduce crowd size at polling stations"; and

WHEREAS, on March 20th, 2020, the Rosebud County Board of Commissioners passed Resolution No. 1076 proclaiming a state of emergency in Rosebud County, Montana; and

WHEREAS, staffing multiple polling sites poses an enhanced risk to public health and human safety due to the COVID-19 pandemic by promoting community transmission of the virus and endangering voters, poll workers, and non-voters alike; and

WHEREAS, §13-19-202, MCA, allows a governing body to request that the Election Administrator conduct an election by use of mail ballots where the voter is unable to vote at the designated polling site.

WHEREAS, the mail ballot provisions of Title 13, Chapter 19, MCA, still allow for in-person voting if the November 3rd, 2020 General Election is conducted by the use of mail ballots and, consequently, Governor Bullock's March 25, 2020 directive includes measures required for safe registration and voting, such as the adoption and enforcement of social distancing policies at polling locations; and

WHEREAS, for a county choosing to conduct the November 3rd, 2020 General Election by mail ballot, Governor Bullock's August 6th, 2020 directive requires the county to expand opportunities for early voting by: (1) making ballots available at the Election Administrator's office or other designated location from October 2nd, 2020 until the end of the election; (2) allowing voters to apply for, receive, and mark a ballot in-person in a manner consistent with § 13-13-222, MCA; (3) sending mail ballots 25 days before the end of the election, on October 9th, 2020, consistent with the timeline for absentee ballots at § 13-13-205, MCA; and (4) including a prominent notice with instructions sent to voters with mail ballots that a postage stamp is not necessary to return the ballot by mail; and

WHEREAS, the Board of County Commissioners of Rosebud County finds that conducting the November 3rd, 2020 General Election with an alternate option to mail in the ballot is necessary to protect the health, safety, and general welfare of the citizens of Rosebud County.

NOW THEREFORE, it is hereby resolved as follows:

1. The Board of County Commissioners of Rosebud County, Montana, hereby requests that the Rosebud County Clerk and Recorder, as Election Administrator for Rosebud County, allow an alternative option for voters for November 3rd, 2020 General Election to mail in their ballot if the voter is unable to make it to the Rosebud County Courthouse polling site.
2. The November 3rd, 2020 General Election mail in ballot alternatives shall be held consistent with

Governor Bullock's August 6th, 2020 directive, including the requirements that the Election Administrator:

- A. Make ballots available at his/her office or other designated location from October 2nd, 2020 until the end of the election;
 - B. Allow voters to apply for, receive, and mark a ballot in-person in a manner consistent with § 13-13-222, MCA;
 - C. Send mail ballots 25 days before the end of the election, on October 9th, 2020, consistent with the timeline for absentee ballots at § 13-13-205, MCA;
 - D. Include a prominent notice with instructions sent to voters with mail ballots that a postage stamp is not necessary to return the ballot by mail; and
3. The Election Administrator shall establish, implement, and enforce the safe registration and voting measures identified in Governor Bullock's August 6th, 2020 directive for all in-person voting for the November 3rd, 2020 General Election.

WHEREAS, Stephanie Hein will complete Coroner training to perform the duties of the office of County Coroner,



WHEREAS, Stephanie Hein is willing to accept the office of County Coroner for Rosebud County, Montana.
