RESOLUTION # 1098

**RESOLUTION OF INTENT TO SELL COUNTY LAND
IN LAME DEER**

WHEREAS, the County desires to sell Rosebud County land in Lame Deer, Montana; and

WHEREAS, pursuant to Section 7-8-2521, MCA, et seq., the County has the authority to dispose of county property; and

WHEREAS, said property is described as: Lots 001 and 002 in Block 006 of the townsite of Lame Deer, Rosebud County, Montana, all according to the official plat on file with the Clerk and Recorder of Rosebud County, Montana; and

WHEREAS, the market value of said real property as determined by the Department of Revenue, lot 001 as \$2630.00 and lot 002 as \$2451.00 for a total of \$5,081.00; and

WHEREAS, the County desires to sell said parcels of land to the highest bidder for a value of not less than the minimum market value of \$5,081.00; and

WHEREAS, the County shall publish said Notice of Sale pursuant to the provisions of Section 7-1-2121, MCA, including to post said Notice of Sale Land at the following locations within the County: The Rosebud County Courthouse in Forsyth, and the Northern Cheyenne Tribal Building in Lame Deer; and

WHEREAS, the County desires to auction said property by accepting sealed bids for a period of two weeks followed by a live auction, a bidder may increase their bid throughout the bidding process until high bid has been established, so long as said increase is also in writing, and

WHEREAS, the bidders must be present at the time of opening of bids and live auction in order to consummate the sale by way of cash or cashier's check; and


WHEREAS, the County shall issue a quitclaim deed within 7 days from the close of said auction; and

THEREFORE, BE IT RESOLVED, that the County shall sell the above-described parcels of land to the highest bid at the close of the live auction; and


