No public comments were received as no public was present for the meeting.

Commissioner Lee motioned to approve Resolution 1099, a resolution requesting to join Big Sky Passenger Rail Authority. Commissioner Joiner seconds motion. Discussion included Commissioner Lee stating a public hearing was held and the public comments were in favor of Rosebud County joining the Big Sky Passenger Rail Authority. Motion carried, 3-0. Resolution 1099 as follows:

RESOLUTION 1099

A RESOLUTION REQUESTING TO JOIN THE BIG SKY PASSENGER RAIL AUTHORITY, ESTABLISHED FOR THE PURPOSE OF PROVIDING FOR THE PRESERVATION AND IMPROVEMENT OF ABANDONED RAIL SERVICE IN SOUTHERN MONTANA

BE IT RESOLVED by the Rosebud County Commission as follows:

Section 1. Authorization. Pursuant to Montana Code Annotated, Title 7, Chapter 14, Part 16, as amended (the "Act"), boards of county commissioners are authorized to create railway authorities. Under the Act, a "railway authority" may be authorized by law as either a county rail authority or by joint resolution by two or more counties the counties may create a regional rail authority. The Act gives a railway authority all the powers set forth in the Act necessary to provide for the preservation and improvement of abandoned rail service, including passenger rail service.

Section 2. Purpose. The purpose of an authority is to provide for the preservation and improvement of abandoned rail service for agriculture, industry, or passenger traffic and to provide for the preservation of abandoned railroad right-of-way for future transportation uses, when determined to be practicable and necessary for the public welfare. The establishment of the Big Sky Passenger Rail Authority provides:

- A means to further the health, safety, welfare, and economic prosperity of the region by advocating for rail as a public transportation option;
- The governance structure to investigate, analyze, seek funding for, and develop long-distance, inter-city rail service across southern Montana; and
- Other undertakings contemplated by the Act.

Section 3. Name of District and Duration. The Regional Rail Authority (Authority), known and designated as the "Big Sky Passenger Rail Authority," was created by a Joint Resolution Creating A Regional Rail Authority, adopted on November 18, 2020 and expanded to include Carbon County on May 12, 2021 pursuant to a Resolution adopted by the Authority. The duration of the Authority is perpetual, provided that, if no bonds, or other debt of the Authority, are outstanding and the Authority determines that it is in the best interest of the counties' inhabitants or that the purpose of the Authority has been fulfilled, the Authority may dissolve the Authority pursuant to the rules established by the Authority.

Section 4. Governance. The powers of the Authority are vested in a board of directors.

(1) Appointment of Directors. The Boards of County Commissioners in the participating counties as of the date of this Resolution appointed the directors of the Authority. If the Authority expands the number of counties, and directors, each Board of County Commissioners in subsequent added counties will make board appointments to the Authority.

(2) Number of Directors. The board membership equals the number of counties in the Authority, with one member appointed by each county.

(3) Qualifications of board members. The appointed directors must have an interest in furthering the mission of the Authority and bring varying expertise and knowledge to the Authority.

(4) Length of term. Each director will be appointed for a term of three years. Initial terms may be staggered as determined by the Board.

Section 5. Proposed Boundaries of District. The limits and boundaries of the Authority may be, as set forth below, enlarged to encompass in the aggregate the boundaries as approved by each participating county. The boundary of the area proposed to be included in the Authority for each county shall be the boundary of the county unless designated otherwise.

Section 6. Rule Making Authority to Enlarge District. The Authority has the authority to adopt rules pursuant to MCA § 7-14-1631, including but not limited to procedural rules for the addition of a county not included in the original joint resolution, with the county requesting to join adopting a resolution and submitting such resolution to the Authority. If this request is granted by the Authority, the Board of County Commissioners of the petitioning county will select, pursuant to its own process, its representative to the board of the Authority.

Section 7. General Powers of Authority. The Authority has all the powers necessary to carry out the purposes of the Act, including but not limited to:

- (1) sue and be sued, have a seal, and have perpetual succession;
- (2) execute contracts and other instruments and take other action as may be necessary to carry out the purposes of the Act;
- (3) receive and disburse federal, state, and other funds, public or private, made available by grant, loan, contribution, tax levy, or other source to accomplish the purposes of the Act. Federal money accepted under this subsection must be accepted and spent by the authority upon terms and conditions prescribed by the United States and consistent with state law. All state money accepted under this subsection must be accepted and spent by the authority upon terms and conditions prescribed by the state;
- (4) sell, lease, or otherwise dispose of real or personal property acquired pursuant to this part. The disposal must be in accordance with the laws of this state governing the disposition of other public property;
- (5) borrow money and issue bonds pursuant to MCA 7-14-1636; and
- (6) all other powers provided by Montana statutory authority.

Section 8. Public Hearing. Pursuant to MCA 7-14-1621(2), the undersigned County certifies that it held a public hearing and published notice of the hearing pursuant to MCA 7-1-2121, and published a copy of this proposed Resolution as required.

Section 9. Request to join. Rosebud County passes this Resolution requesting to join the Big Sky Passenger Rail Authority. The Board of County Commissioners of Rosebud County authorizes and directs that the Resolution be presented to the directors of the Authority for consideration by such directors in the manner set forth below. Upon confirmation from the Authority, the Commission will appoint a member to the board.

Section 10. Required Actions by Directors of Authority. The Board of County Commissioners of Rosebud County understands and agrees that the addition of Rosebud County as a participating county in the Authority requires subsequent action of the directors of the Authority. Upon adoption

of this resolution following a public hearing and presentation of this resolution to the directors of the Authority, the directors of the Authority will cause to be scheduled and will conduct a duly noticed public hearing at which time the directors of the Authority will hear public comment on whether to add Rosebud County as a participating county in the Authority, the boundaries of the authority if it is to be enlarged, and any other matters that may be relevant.


Following the public hearing, which may be continued from time to time, the directors of the Authority, if it is determined to add Rosebud County as a participating county in the Authority, shall adopt a resolution adding Rosebud County as a participating county in the Authority, specifying the new boundaries of the Authority, as enlarged by the addition of Rosebud County, and addressing such other matters as may be relevant.

RESOLUTION# 1100

Resolution to Purchase Oil, Services and Winter Maintenance from the State of Montana

WHEREAS; Rosebud County has agreed to purchase oil and services from the State of Montana, Department of Highways, and;

WHEREAS; the amount of oil and services needed may vary each year depending on the type of work needing done,

NOW THEREFORE BE IT RESOLVED; that the State of Montana agrees to provide oil and Magnesium Chloride as needed; and provide winter maintenance services on all county roads as specified:


- Intersections in Ashland
- The first 0.7 miles up the Birney/Ashland Road
- Around the corner at the intersection of Cartersville and S446
- The overpasses on the first 3 miles of the Castle Rock Road, beginning at mile marker 0.0 on Highway 39 to mile marker 3.0

Rosebud County will reimburse the State of Montana, Department of Highways for any oil and services provided to the County for its use.



RESOLUTION # 1101

Resolution Setting County Elected Official Salaries

On a motion by Commissioner Martens and seconded by Commissioner Joiner in Regular Session on July 14, 2020, it carried to unanimously approve the following County Elected Official salaries for the fiscal year beginning July 1, 2020 and ending June 30, 2021.

WHEREAS; Section 7-4-2504 MCA requires the county governing body to fix salaries of all elected officials;

THEREFORE, BE IT RESOLVED; the salaries will be increased as recommended by the Rosebud County Salary Compensation Board. The salaries will thus be as follows:

- The County Clerk of the District Court, Justice of the Peace, Clerk and Recorder, and Treasurer shall receive \$62,484.02 base salary + \$2,000.00 to equal \$64,484.20
- The County Superintendent of Schools shall receive the elected officials' base salary, or \$62,484.02 + \$400.00 annually for a total of \$62,884.02.
- The County Attorney, as a full-time County Attorney, shall receive \$118,791.27 base salary.
- The County Commissioners and Sheriff will receive \$64,484.20 base salary.
- The County Coroner shall receive \$587.65 per month and Deputy Coroners shall receive \$452.88 per month.

Passed and adopted this 24th day of June, 2021 but will be effective as of July 1, 2021.

Commissioner Lee motioned to approve Resolution 1102 a resolution for Special Fire Restriction Stage 1. Commissioner Joiner seconds motion. Discussion included Commissioner Joiner stating that other counties in the state are under extreme conditions, Rosebud County is not under as bad of conditions but stage one is a good place to start. Commissioner Martens stated it would be effective beginning at midnight July 1st, 2021. Motion carried, 3-0. Resolution 1102 as follows:

RESOLUTION # 1102

SPECIAL FIRE RESTRICTION – STAGE 1

WHEREAS; Counties are currently experiencing increased fire activity due to fuel conditions getting very dry, the chance of ignition increases daily as the fuels are drying out. Fire danger levels are expected to continue in the range between very high and extreme; and

WHEREAS; The rapid onset and movement of fire may require Incident Commanders and law enforcement agencies to act immediately and at any time to protect persons and their property; now

BE IT FURTHER RESOLVED; that Rosebud County Commissioners is declaring a Stage 1 Fire Restriction to be effective MIDNIGHT, Thursday July 1st, 2021 and be in effect until further notice. The following acts are prohibited:

1. Building, maintaining, attending, or using a fire or campfire, unless noted in exemptions below.
2. Smoking, except within an enclosed vehicle or building, a developed recreation site or while stopped in an area at least three feet in diameter that is barren or cleared of all flammable materials.

EXEMPTIONS:


- a. Persons with a written permit that specifically authorized the otherwise prohibited act.
- b. Persons using a fire solely fueled by a liquid petroleum or LPG fuels.
- c. Persons conducting activities in those designated areas where the activity is specifically authorized by written posted notice.
- d. Any Federal, State, or local officer or member of an organized rescue or firefighting force in the performance of an official duty.
- e. All land within a city boundary is exempted.
- f. Other exemptions unique to each agency.
