WHEREAS; pursuant to 7-6-4030, MCA, the Board of County Commissioners of Rosebud County must adopt a final budget by resolution after the budget has been balanced so that appropriations do not exceed the projected beginning balance plus the estimated revenue of each fund for the year;







WHEREAS; anyone who causes a wildland fire intentionally or through negligence may be held accountable for damage and suppression costs; and


