Martens, Presiding Officer, Robert E. Lee, Member, Ed Joiner, Member, Josh Jonas, Deputy Sheriff and Clerk & Recorder, present.

No public comments were received as no public was present for the meeting.

Commissioner Joiner motioned to approve the consent agenda, to include all claims and to approve the July minutes. Commissioner Lee seconds motion, motion carried, 3-0.

Commissioner Lee motioned to award the Tillitt Field Airport project bid for the hanger construction to Young Guns Construction. Commissioner Joiner seconds motion. Discussion included Commissioner Lee stating they were the only bidders for the project. The total amount of the project was bid for \$786,172.50. Commissioner Joiner stated that because it is an FAA Grant the contribution from the County is only ten percent. Motion carried, 3-0.

Commissioner Lee motioned to appoint Deputy Sheriff, Josh Jonas as Rosebud County Coroner. Commissioner Joiner seconds motion. Discussion included Commissioner Martens stating it was necessary to fill the vacancy caused by the passing of the previous coroner, Stephanie Hein. Josh Jonas has placed his name on the ballot to run in the General Election in November. He was the only person interested in filling the current vacancy to fulfill the

term. Commissioner Joiner stated that it is necessary to appoint a responsible responding party, and Josh fills that role. He will attend the coroner training in December. Motion carried, 3-0. Resolution 1135 as follows:


