The Board of County Commissioners of Rosebud County, Montana, met in Regular session on November 1<sup>st</sup>, 2022 at 10:00 a.m. in the Rosebud County Courthouse Commissioners' Office, with Douglas D. Martens, Presiding Officer, Robert E. Lee, Member, and Clerk & Recorder, present.

No public comments were received as no public was present for the meeting.

Commissioner Lee motioned to approve the consent agenda, to include all claims. Commissioner Martens seconds motion, motion carried, 2-0.

Commissioner Lee motioned to approve the amendment for the Rosebud County Landfill Equipment Lease with Brown's Excavation. Commissioner Martens seconds motion. Discussion included Commissioner Martens stating Rosebud County will take over maintenance of equipment effective immediately, contract payments will continue until December 2023, at that time the County will assume ownership of the equipment which is two compactors and a scraper. Motion carried, 2-0.

Commissioner Lee motioned to approve the Memorandum of Understanding between the Department of Interior BLM and Rosebud County, for sage grouse management. Commissioner Martens seconds motion. Commissioner Martens stated this will allow Rosebud County to be a cooperating agency with BLM in the management plan division. Motion carried, 2-0.

Commissioner Lee motioned to approve Resolution 1144, a resolution Directing the County Treasurer to Issue Tax Deed. Commissioner Martens seconds motion, motion carried, 2-0. Resolution as follows:

## Resolution 1144

### A RESOLUTION DIRECTING THE COUNTY TREASURER TO ISSUE TAX DEEDS

**WHEREAS**, pursuant to 15-18-211, M.C.A, the County Treasurer may not issue tax deed to the county (if the purchaser is the county and no assignment has been made) unless the Board of County Commissioners, by resolution, directs the County Treasurer to issue a tax deed; and

**WHEREAS**, the Rosebud County Commissioners, direct the Rosebud County Treasurer to issue a tax deed on property, where the county is the purchaser and no assignment has been made, and on which the taxes have not been paid prior to issuance of the tax deed;

**NOW, THEREFORE, BE IT RESOLVED:**

1. That the County Treasurer shall issue tax deeds to the county for that property where the county is the purchaser and no assignment has been made, as specifically described as Property Specifically described as: Lots 7 and 8, Block 7, of the Town of Forsyth, Rosebud County, Montana according to the official plat thereof on file and of record in the office of the County Clerk and Recorder of Rosebud County, Montana; and on which property the taxes are not paid before issuance of tax deed.
2. Prior to the issuance of tax deeds, the County Treasurer shall comply with the notice requirements of 15-18-212, M.C.A.

**WHEREAS**, the County will receive additional Windfarm Impact Money in FYE 2023:


**WHEREAS**, the County must do a Budget Amendment to spend this money as it was not included in the FYE 2023 Budget;
