The Board of County Commissioners of Rosebud County, Montana, met in Regular session on July 18<sup>th</sup>, 2023 at 10:00 a.m. in the Rosebud County Courthouse Commissioners' Office, with Ed Joiner, Presiding Officer, Scott Hein, Member, Ryan Plympton, County Trapper and Clerk & Recorder, present.

No public comments were received as no public was present for the meeting.

Commissioner Hein motioned to approve the consent agenda, to include all claims, and to approve the June minutes. Commissioner Joiner seconds motion, motion carried, 2-0.

Discussion regarding a Memorandum of Understanding with Montana Stockgrowers Association that is set to renew ensued. Currently Rosebud County has an agreement to pay \$10,000 for protection of cattle from destructive animals. Ryan Plympton, County Trapper, mentioned the overall loss of cattle in the county and believes that decreasing the support by \$2500.00 would be in the best interest of

the county. He mentioned that the Predator Control Board also voted to split the loss and contribute \$7500.00. The current cost per head for cattle is \$0.50 and \$0.60 for sheep, there was a discussion regarding increasing that. No action regarding that taken at this time, it will be sent to the Predator Board for further discussion.

Commissioner Hein motioned to reduce the contribution from the county to \$7500.00. Commissioner Joiner seconds motion, motion carried, 2-0.

Commissioner Hein motioned to table discussion regarding the Cemetery Policies and Prices due to Steve Fourtner, Cemetery Supervisor being unable to attend this meeting. Commissioner Joiner seconds motion, motion carried, 2-0.

Commissioner Hein motioned to approve the Pledged Securities as presented by Kathy Fahrenbruck, Rosebud County Treasurer. Commissioner Joiner seconds motion, motion carried, 2-0.

Commissioner Hein motioned to approve Resolution 1173, a Budget Resolution for Fiscal Year 2023. Commissioner Joiner seconds motion, motion carried, 2-0. Resolution 1173 as follows:





No public comments were received as no public was present for the meeting.

Commissioner Lee motioned to approve the consent agenda, to include all claims. Commissioner Hein seconds motion, motion carried, 3-0.

Now is the time set to discuss safety concerns on West Armells Creek Road. Present for this discussion were Grant Larsen, Road Supervisor, Undersheriff Scott McDermott, Sgt John O'Toole, and Dick DeCock, county resident.

A concern was presented by Mr. DeCock regarding speed limit issues on the road with hauling trucks. The Commission agreed that signage would help with speeding issues. Speed limits on all County Roads are currently set at 40 mph for trucks and all other vehicles are set at 45mph. Representatives of the Sheriff's Department stated they would patrol the area of West Armells Creek Road more. The Road Department will supply the speed limit signs and cattle at large signs and install them to address the safety concerns.
