No public comments were received as no public was present for the meeting.

Commissioner Lee motioned to approve the consent agenda, to include all claims and to approve the August minutes. Commissioner Hein seconds motion, motion carried, 3-0.

Commissioner Lee motioned to approve Resolution 1174, a Resolution Adopting the Budget for Rosebud County FY 2023-2024. Commissioner Hein seconds motion. Discussion included Commissioner Joiner stating that the budget was reviewed by each department head and was made available to public for review and comment. Motion carried, 3-0. Resolution 1174 as follows:

RESOLUTION 1174

A RESOLUTION ADOPTING THE FINAL OPERATING BUDGET AND SETTING APPROPRIATION AUTHORITY FOR THE FISCAL YEAR BEGINNING JULY 1, 2023 AND ENDING JUNE 30, 2024

WHEREAS, Section 7-6-4030, MCA, provides that the governing body shall adopt the final budget by resolution. The resolution must:

- (a) Authorize appropriations to defray the expenses or liabilities for the fiscal year;
- (b) Establish legal spending limits at the level of detail in the resolution; and
- (c) Include any increase in property taxes, including an increase authorized under 15-10-420(1) and the amount by which property taxes will increase on homes valued at \$100,000, \$300,000 and \$600,000.

WHEREAS, Section 7-6-4020 requires that a preliminary annual operating budget must be prepared for the local government; and

WHEREAS, Section 7-6-4021 requires that the governing body shall cause a notice of public hearing on the preliminary or amended budget to be published, and

WHEREAS, Section 7-6-4024, provides that the governing body must hold a public hearing in accordance with the notice given pursuant to 7-6-4021; and

WHEREAS, The Board of County Commissioners held a public hearing on September 5th, 2023 where residents of the County were allowed to express their concerns about the proposed budget; and

WHEREAS, The Board of County Commissioners has reviewed the proposed budget, received the estimated ending cash balances for all county funds, made changes to the budget as deemed necessary following the public hearing(s) and from input by elected officials and department heads, and computed the estimated taxes, fees and assessments needed to fund the fiscal year 2024 budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Rosebud County that:

The final budget after any amendments to the preliminary budget and after considering any public comment is adopted.

This resolution authorizes:

- (a) Appropriations to defray the expenses or liabilities for the fiscal year.
- (b) It sets the legal spending limits at the county fund level. Fund level detail is stated in the formal budget document and established in the County's accounting system.

(c) An increase(decrease) in property taxes due to (15-10-420 calculation), permissive and/or voted levies of \$18.25, \$54.75, and \$109.50, respectively for a home valued at \$100,000, \$300,000 and \$600,000 is included in this fiscal year budget.

The effective date of this resolution is July 1, 2023, even if the resolution is adopted after that date.

Commissioner Hein mentioned the increase in mills for the library, Emergency Service and Senior Center Services. Commissioner Lee stated the discussion the County had with the City of Colstrip regarding the cemetery transfer it was agreed that the mills would not be levied for the cemetery for all county residents. It was also noted that the Road Mills reduced from 54 to 49. Commissioner Hein mentioned that the \$12.00 TV District fee will be waived for Forsyth and Colstrip which will help offset the number of mills being increased. Motion carried, 3-0. Resolution 1175 as follows:

WHEREAS, NOTICE, is hereby given that the Rosebud County Budget for 2023-2024 has been Adopted by Resolution 1174, pursuant to 7-6-4030, MCA,

WHEREAS, The Board of County Commissioners have reviewed each budget and have determined the mill levy necessary for operating each department, and

THEREFORE, BE IT RESOLVED, by the Board of Rosebud County Commissioners, in a meeting September 5, 2023, established that the levies for the operation of Rosebud County for the fiscal year 2023-2024 will be Adopted as per attached Levy Requirement Schedule, and

BE IT FURTHER RESOLVED, that the Clerk and Recorder forward a copy of said Resolution to the Rosebud County Treasurer and the Department of Revenue, State of Montana.
