The Board of County Commissioners of Rosebud County, Montana, met in Regular session on June 20th, 2024 at 10:00 a.m. in the Rosebud County Courthouse Commissioners' Office, with Ed Joiner, Presiding Officer, Robert E. Lee, Member, Scott Hein, Member, and Clerk & Recorder, present.

No public comments were received as no public was present for the meeting.

Commissioner Lee motioned to approve the consent agenda, to include all claims. Commissioner Hein seconds motion, motion carried, 3-0.

Discussion ensued regarding the four percent (4%) salary increase as recommended from the Compensation Board.). Further discussion ensued regarding employee raises.

Commissioner Lee motioned to approve the salary increase for Elected Officials based on recommendations by the Compensation Board of four percent (4%). Commissioner Hein seconds motion. Discussion included Commissioner Lee stating at the meeting, held on June 4th, 2024, it was decided that a pay increase would be granted based on numbers provided by the Montana Association of Counties (MACo) correspondence using the Consumer Price Index (CPI) recommended a 4.1% which has been used for numerous years as determined by the US Department of Labor and the federal cost of living adjustment was 3.2% used for social security. Motion carried, 3-0. Resolution 1194 as follows:

RESOLUTION # 1194

Resolution Setting County Elected Official Salaries

On a motion by Commissioner Lee and seconded by Commissioner Hein in Regular Session on June 20th, 2024, it carried to unanimously approve the following County Elected Official salaries for the fiscal year beginning July 1, 2024 and ending June 30, 2025.

WHEREAS; Section 7-4-2504 MCA requires the county governing body to fix salaries of all elected officials;

THEREFORE, BE IT RESOLVED; the salaries will be increased as recommended by the Rosebud County Salary Compensation Board. The salaries will thus be as follows:

The County Clerk of the District Court, Justice of the Peace, Clerk and Recorder, and Treasurer shall receive \$74,042.06 base salary + \$2,000.00 to equal \$76,042.06

The County Superintendent of Schools shall receive the elected officials' base salary, or \$74,042.06 + \$400.00 annually for a total of \$74,442.06.

The County Attorney, as a full-time County Attorney, shall receive \$140,764.80 base salary.

The County Commissioners and Sheriff will receive, \$76,042.06 base salary.

The County Coroner and Deputy Coroners shall receive compensation for their time.
