The Board of County Commissioners of Rosebud County, Montana, met in Regular session on October 1<sup>st</sup>, 2024 at 10:00 a.m. in the Rosebud County Courthouse Commissioners' Office, with Ed Joiner, Presiding Officer, Robert E. Lee, Member, Scott Hein, Member, and Clerk & Recorder, present.

No public comments were received as no public was present for the meeting.

Commissioner Lee motioned to approve the consent agenda, to include all claims. Commissioner Hein seconds motion, motion carried, 3-0.

Commissioner Lee motioned to approve Resolution 1201, a resolution to Change Tax Assessment Fee for Rosebud County Landfill. Commissioner Hein seconds motion. Discussion included Commissioner Hein stating a public meeting was held and the landfill board met to discuss the need to increase the tax assessment fee from 85 to 125. Commissioner Joiner stated the \$85.00 has been in place for past 12 years the county has tried to get by without an increase but everything is more expensive. Commissioner Hein stated there is a need for updating machinery and this will also help with that. Motion carried, 3-0. Resolution 1201 as follows:

**RESOLUTION 1201**

**RESOLUTION TO CHANGE TAX ASSESSMENT FEE FOR ROSEBUD COUNTY LANDFILL**

**WHEREAS**, Rosebud County maintains a solid waste disposal operation;

**WHEREAS**, the Fees to maintain and operate the Landfill were established in 1995 last changed in 2018;

**WHEREAS**, solid waste disposed at the landfill has been increasing;

**WHEREAS**, the landfill is classified in the BARS system an enterprise fund which must be supported by fees for its operation;

**WHEREAS**, due to increased maintenance costs and loss of off-site disposal contract, the landfill fees must be increased;

**WHEREAS**, the Solid Waste Board and the Commissioners proposed to increase the Unit Fee from \$85.00 to \$125.00;

**WHEREAS**, a public hearing was held on September 10<sup>th</sup>, 2024;

**NOW, THEREFORE BE IT RESOLVED**, after receiving no public comments, for or against the change, the Board of County Commissioners moves to adopt the above fee change;

**BE IT FURTHER RESOLVED**, this Resolution becomes effective October 1<sup>st</sup>, 2024.


