The Board of County Commissioners of Rosebud County, Montana, met in Regular session on June 2nd, 2026, at 10:00 a.m. in the Rosebud County Courthouse Commissioners' Office, with Scott Hein, Presiding Officer, Robert E. Lee, Member, Sally Wanner, Clerk & Recorder, Hunter Harbaugh, Independent Press, and Jay Lieschner, Transource Truck & Equipment, present.

No public comments were received as no public was present for the meeting.

Commissioner Lee motioned to approve the consent agenda, to include all claims. Commissioner Hein seconds the motion; the motion carried, 2-0.

Now comes the time to appoint the post-election audit board. Kathy Fahrenbruck, Stephani Grogan, and Kimberly Knoche will serve on the board. Commissioner Lee motions to approve. Commissioner Hein seconds the motion, motion carried, 2-0

A bid opening was held for the purchase of a New Model Roll-Off Truck for the county landfill. Commissioner Hein announced that one sealed bid was received and proceeded to open and announce the details of that bid. The bid was received by Transource Truck & Equipment. Two Mack Granite 84FR bid options were enclosed. One option was for a 13-speed manual transmission, and the other for an M-drive. Transource company representative, Jay Leischner explained that the M-drive can be driven by a CDL-endorsed driver without the manual CDL endorsement. The M-drive can be driven in manual mode with push buttons on the steering wheel if the driver chooses. Both bids will be the same cost \$254,201.14, and will be delivered 240 to 260 days following receipt of the order. The bid bond for 10% of the net bid was attached. Commissioner Lee made a motion to take the bid under advisement for two weeks. Commissioner Hein seconds the motion; the motion is carried, 2-0.

There being no further business to come before the Board at this time, they adjourned sine die.

The Board of County Commissioners of Rosebud County, Montana, met in Regular session on June 9th, 2026, at 10:00 a.m. in the Rosebud County Courthouse Commissioners' Office, with Scott Hein, Presiding Officer, Robert E. Lee, Member, Ed Joiner, Member, Sally Wanner, Clerk & Recorder, Allen Fulton, Sheriff, Amy Adler, Weed department, Hunter Harbaugh, Independent Press, and Doug Roberts, present.

No public comments were received as no public was present for the meeting.

Commissioner Lee motioned to approve the consent agenda, to include all claims and May minutes. Commissioner Joiner seconds the motion; motion carried, 3-0.

Now comes the time to approve Resolution #2026-18, setting the raises for Rosebud County Elected Officials and county employees. Commissioner Lee makes a motion to increase pay by 3% for elected officials and \$1.25 for county employees. Discussion includes Commissioner Lee stating the 3% raise would be roughly \$1.10 hr. This was a recommendation by the compensation board. County employees will receive a \$1.25 raise, except for deputies whose raises are set by base wage. An additional benefit to this increase in pay will be the insurance premium that the county will pay. The county will be paying an additional \$2.00hr or \$500 monthly per employee for insurance. Pay increases will go into effect on July 1, 2026. Commissioner Joiner seconds this motion, motion carried, 3-0

Commissioner Lee now makes a separate motion to set the County attorney's cost of living increase to 3%. This increase was accepted by the county attorney and will go into effect on July 1, 2026. Commissioner Joiner seconds the motion; motion carried, 3-0

RESOLUTION # 2026-18

Resolution Setting County Elected Official Salaries

On a motion by Commissioner Lee and seconded by Commissioner Joiner in Regular Session on June, 9th, 2026, it carried to unanimously approve the following County Elected Official salaries for the fiscal year beginning July 1, 2026 and ending June 30, 2027.

WHEREAS; Section 7-4-2504 MCA requires the county governing body to fix salaries of all elected officials;

THEREFORE, BE IT RESOLVED; the salaries will be increased as recommended by the Rosebud County Salary Compensation Board. The salaries will thus be as follows:

The County Clerk of the District Court, Justice of the Peace, Clerk and Recorder, and Treasurer shall receive \$78,551.22 base salary + \$2,000.00 to equal \$80,551.22.

The County Superintendent of Schools shall receive the elected officials' base salary, or \$78,551.22 + \$400.00 annually for a total of \$78,951.22.

The County Attorney, as a full-time County Attorney, shall receive \$149,337.37 base salary.

The County Commissioners and Sheriff will receive, \$80,551.22 base salary.

Now is the time to approve the MOU between Rosebud and Treasure County for the weed district. Commissioner Lee makes the motion to approve. Discussion includes Amy Adler explaining that Treasure County has not had a weed department for 3 years and has struggled to find certified people to spray and who know weed law. They are contracting it out, but only for so long. Amy was approached by Treasure County to assist with their weed department at a wage of \$40.00/hr. This will not be a full-time position, but rather to assist occasionally. Commissioner Joiner seconds the motion; motion carried, 3-0

Now is the time to approve the Ashland canister site. Commissioner Lee makes a motion to approve. Discussion includes Commissioner Joiner stating that we had trouble with the canister site previously, but the land that it sits on is now owned by Ashland Public Schools. Ashland Public has agreed to lease this site for \$150.00 annually. Allowing us to lease this site saved Rosebud County the money it would have cost to move the canister to a different location. Commissioner Joiner seconds the motion to approve. Motion carried, 3-0

It is now time for the bid opening for a 1997 F-250 truck that is part of the county surplus inventory. Commissioner Hein states that we have received three bids. Bid one comes from Dave Quenzer in the amount of \$120.00. Bid two is from Doug and Vallerie Roberts in the amount of \$501.00. Bid three was delivered by Wayne Buck in the amount of \$500.00. Commissioner Lee makes a motion to accept Doug and Vallerie's bid. Commissioner Joiner seconds the motion, motion carried, 3-0

Commissioner Joiner makes a motion to approve. The discussion included Commissioner Lee explaining that we have done this for a couple of years now. Resolution to Purchase Oil, Services and Winter Maintenance from the State of Montana

WHEREAS; Rosebud County has agreed to purchase oil and services from the State of Montana, Department of Highways, and;

WHEREAS; the amount of oil and services needed may vary each year depending on the type of work needing done,

NOW THEREFORE BE IT RESOLVED; that the State of Montana agrees to provide oil and Magnesium Chloride as needed; and provide winter maintenance services on all county roads as specified:

- Intersections in Ashland
- The first 0.7 miles up the Birney/Ashland Road
- Around the corner at the intersection of Cartersville and S446
- The overpasses on the first 3 miles of the Castle Rock Road, beginning at mile marker 0.0 on Highway 39 to mile marker 3.0

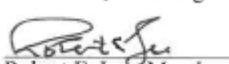
Rosebud County will reimburse the State of Montana, Department of Highways for any oil and services provided to the County for its use.

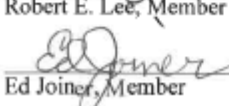
